## APPLICATION FOR AN OFFSHORE LICENSE (EIGHTH SCHEDULE, FISHERIES REGULATIONS

(Regulation 4A, 4B & 5A)

This application refers to fishing for any of the fish species listed under the Fishery Categories described by the Seventh Schedule of the Fisheries (Amendment) Regulations of 1990. It is illegal to fish for any of the fish species listed under the Seventh Schedule, outside the limit of the Internal Waters of Fiji, unless an Offshore License is held on board the vessel.

The holding of an Offshore License for a Fiji Fishing vessel does not preclude the necessity for the skipper or Fishing Master of that vessel to hold a valid Fishing License and Fishing Vessel Registration under sections 5 & 6 of the Fisheries Act. However, an Offshore License is specific to a Fiji Fishing Vessel and not to a Skipper or Fishing Master.
